- ✓ Maintain an established outside Builder Sales force dedicated and trained to call on Home Builders.
- ✓ Maintain operations resources dedicated to handling and serving Builder Sales transactions and fulfillment.
- ✓ Display adequate F&P/DCS products on the sales floor, as agreed upon by a F&P Builder Development Manager (BDM) and Territory Manager (TM), that showcase examples of each product type available in the Cook, Cool, Clean + program.
